SUPERVISOR COMMENTS

This Friday was a very busy shift. In addition to the regular calls for service, the city had its July 4th Parade which added to the traffic congestion and amount of people downtown. During the shift officers responded to a female who stated she was assaulted by someone in her family. As it turned out, she was extremely intoxicated (and has a history of this). Prior to calling the police, the caller had fell backwards, due to her intoxication, and cause the injury she sustained. This was corroborated by all the family members at the residence. The caller was taken to a hospital for treatment. Officers responded to a violation of a court order. The victim had a restraining order against her neighbor. The neighbor was pounding on her door, stating the cartel was after him and she needed to let him inside so he could hide knives in her home. When officers arrived, they located the suspect. When they tried to detain him he resisted, but was eventually placed in handcuffs. He was taken to jail. Officers also investigated a domestic violence in which the male threw a container of urine on the female. He was located and arrested as well.
