SUPERVISOR COMMENTS

This morning, an officer responded to a report of a suspicious female entering backyards of a mobile home park. The officer located the female walking in the road who appeared to be under the influence of drugs. She refused to stop when ordered to and tried to walk away. She was arrested for obstructing/delaying a peace officer. She gave a false name but her true identity was determined. She was a parolee at large out of Stockton and had felony warrants. She was booked. Other than this, the rest of the day was ordinary with calls for service.

SUPERVISOR COMMENTS

The shift started out with a weapon offense in-progress. Officers rushed out of briefing to respond to a report with sounds of people screaming and gunshots heard. Two

officers were close by and arrived quickly. As they arrived a male was seen running down an alley and officers lost sight of him in an apartment complex. Another male juvenile who was involved was quickly detained by officers. A witness pointed officers to a detached laundry room in the complex. Officers discovered the door was locked and obtained a key from a resident. After officers entered they located the male who ran hiding inside. He was determined to be a victim of the incident, but had a felony warrant and was arrested. The detained juvenile was determined to be the other victim but was uncooperative with officers. The investigation determined the two victims are drop-out gang members and were approached by 4 gang members who were in a vehicle. After a verbal altercation one of the males in the vehicle fired approximately 3 shots at the victims. They fled the area in a vehicle before police had arrived. Nobody was hit by gunfire and three shell casings were recovered from the scene. No suspects have been identified.

SUPERVISOR COMMENTS

Tonight was a relatively quiet night for the graveyard shift. Officers spent some of the shift looking for subject who were wanted on warrants, and I&B's from previously investigated incidents. During this shift, officers arrested a subject who was wanted. He was subsequently transported to the jail. While en-route to the jail, the transporting officer heard the sound of a metallic object hitting the floorboard. When he opened the car door, the officer located a stolen handgun on the floorboard of the vehicle. The firearm was listed as being previously stolen. Additional charges were added to the suspects original boking, all for firearms related crimes.
