Dayshift was steady but manageable. Officers handled a handful of traffic collisions, with only one causing injury. An officer drove past a location known for trespassers and recognized a male who had been admonished several times for trespassing. The male was arrested for trespassing again and had drug paraphernalia in his possession, for an additional charge. An officer saw a male walking who he recognized as being wanted for vehicle theft. The male was stopped and lied about his name until his ID was located on him. He was confirmed to be the wanted subject and arrested. He was booked for vehicle theft charges and for providing false info to an officer.

SUPERVISOR COMMENTS

Officers responded to a dangerous driver call. When they located the vehicle they contacted a heavily intoxicated female in the driver seat. She was unable to perform field sobriety tests due to her level of being impaired. A breath sample showed a BAC of .39. She was arrested, and due to having heart issues, AMR was called out and advised she needed medical. She was released with a citation and transported to the hospital. Officers responded to a beer-run larceny involving two males. They were located nearby and found to be intoxicated. The store did not want to press charges for the theft, so they were booked for public intoxication. Officers also responded to a security check after a 911 hang-up call. It was determined that a male was in an argument with the mother of his child. They argued over dirty laundry and the male refusing to buy baby formula from the store. During their altercation, the male kicked the victim in the stomach. He was arrested for domestic battery.

SUPERVISOR COMMENTS

While this shift was not overly busy with calls for service, the calls that we did respond to took some time to complete. During the shift, officers made a traffic stop and arrested the driver for warrants, as well as felony narcotics charges. Later on, the Sheriff's dept were involved in a pursuit that came into our city. I sent officers to assist, and the pursuing Sheriff deputy cancelled the pursuit near the north area of town. The Sheriff helicopter kept following the vehicle and it crashed into a parked car in the north east portion of town. The occupants fled from the car, but were located hiding nearby. Our officer took the collision report, since it happened in our jurisdiction. Additionally, I lost an officer in order to watch a prisoner at Doctors Hospital. A female was arrested for felony warrants, and the jail refused to accept her without medical clearance. When at the hospital, medical staff determined she needed a blood transfusion before they would medically clear her to be booked into jail.
