### SUPERVISOR COMMENTS

Today was busy all day. This morning, an officer investigated a theft and fraud case where the victim had discarded expired credit cards and they were used by the suspect in three fraudulent transactions. The officer obtained video of the suspect who was recognized by another officer. The suspect was located later this afternoon, pulled over in his car, and arrested for the fraud. He was also booked for driving with a suspended license and probation violation. This afternoon, officers investigated a domestic violence call where the victim was strangled by her boyfriend and then prevented from calling police by him. He fled the area in his vehicle prior to officers arriving. He will be tracked down for felony domestic violence charges. At the end of the shift, a male was contacted found to be too intoxicated to care for himself. He was booked so he could sober up.

### SUPERVISOR COMMENTS

Tonight was an active night. Officers were kept busy responding to numerous calls for service. Around 2230 hours, officers responded to a female who said she was dragged by 5 males and that they also brandished handguns at her. It turned out that the victim was at a residence with the group of males, when an argument ensued. She started walking towards a vehicle, when she claimed to have been grabbed by 5 males and they started pulling her to the vehicle. She was able to get away from their grasp, and she stated they started brandishing handguns at her. She claimed one of the males had a laser pointer on a handgun and the laser was being pointed at her head. Officers surrounded the home and made announcements. 5 males exited the residence and all were detained. One of the males was on probation, and the residence in question was his probation address. A search was conducted and a total of 3 handguns were located in the backyard. One of the handguns had an attached laser. Also, one of the handguns did not have a serial number and was a "ghost gun". In the end, all 5 males were arrested and taken to jail/juvenile hall. 2 were adults and 3 were juveniles. All were arrested on charges that spanned from illegal possession of firearms, to kidnapping.
