SUPERVISOR COMMENTS

Today was a busy day with some really good police work resulting in suspects going to jail. Officers responded to a disturbance call involving two males and a knife. When the dust settled, it was determined one male had pulled out a switchblade knife during the argument. He tried to slash the other male with it but was unsuccessful. The suspect fled the scene on foot but was located by keen officers. He was booked for assault with a deadly weapon and felony probation violation. Officers responded to a burglary in progress where a male was seen on surveillance cameras inside the victim's home. Officers flooded the area and the suspect was located a few blocks away, after jumping fences. The suspect was a 16-year-old, male juvenile wanted by Juvenile Probation Department. He had items in his backpack from the house he burglarized and was bleeding from his hand, from the window he broke to get into the residence. He was booked in Juvenile Hall for burglary and his warrant. A less exciting arrest occurred on a call of a homeless woman trespassing. She had a warrant out of Merced County for trespassing.

SUPERVISOR COMMENTS

An officer investigated a call involving threats made to the victim. The victim's friend has a boyfriend who called the victim and told her he knows where she lives and he is going to kill her. The victim believes the male is gang related and lives in Atwater. She was afraid but did not want prosecution. Officers also investigated a burglary with possible suspects. The victim was out of the country for over a month. When he returned home his place was ransacked and several items had been taken. Neighbors recalled seeing two people within the last week going in and out of the residence. The victim suspects a male who he had evicted was involved. Follow-up is still needed, as a neighbor has video surveillance of the incident.
