SUPERVISOR COMMENTS

Our last work night of this week was not to busy, and officers utilized the lull to complete previous felony reports and perform follow-up. During this shift, officers made a traffic stop on a bicyclist, and during the encounter they discovered he had a concealed knife. He was arrested and taken to jail. Officers also investigated a domestic battery that occurred previously in the week. The suspect was not in the area at the time of the investigation, and he is currently wanted for several felony charges. The only incident of note was thanks to the Sheriff's department. They were involved in a pursuit that came into the city. They notified us of the pursuit, and asked if we could utilize a spike strip to disable the car. CHP was also involved and they were able to use a spike strip to disable the car before we were able to get into position. The vehicle stopped in a commercial area of Turlock and the driver ran from the car. He was apprehended by a Sheriff K9.
