#### **SUPERVISOR COMMENTS**

Swing shift had a busy night. Officers responded to a strong-arm robbery after a male took someone's clothing and threatened the victim when he was confronted. The suspect was intoxicated when officers located him. He was arrested and booked.

Officers responded to a larceny in-progress at a store. When they arrived they saw the suspect riding away on a bike. When they tried to stop him the suspect fled. Officers chased him and eventually took him in custody. He was booked for theft and resisting. Officers were also dispatched to the hospital for the report of a man having a gun and making threats to shoot everyone. The caller was a patient in the ER room who could not see the person yelling but could hear the threats and called 911. The whole shift responded and arrived about the same time. Everything from the front appeared normal, and after making a phone call into the hospital, we were advised by the nurse that everything was fine. A mental patient had apparently made threats that he had a gun and was going to shoot people, but he was strapped to a bed and was awaiting transport by AMR to another facility. Everything was confirmed to be ok and officers cleared.
