Later in the shift officers were contacted by the subject's family, who now have video of her being the victim of domestic violence earlier in the week. The video and testimony were found to be credible and the boyfriend was arrested. Officers also made several other arrests during the day, ranging from narcotics to public intoxication.

**SUPERVISOR COMMENTS**

Officers were flagged down by a female regarding a disturbance. She reported a male had been following her since his release from jail earlier in the day. The male was restrained from the female and was contacted walking away from the area. He was arrested and booked for violating the court order. Officers responded to a downtown bar for a fight, two intoxicated males were contacted and determined to be involved. One of the males damaged a vehicle in the parking lot during the altercation and the owner of the vehicle wanted to press charges. The male was arrested and booked for vandalism and his friend was booked for public intoxication. An officer made a traffic stop on a male driver who had a misdemeanor warrant. While arresting him for the warrant the SO called and notified TPD they were serving a search warrant at the male's house for firearms manufacturing and requested that we book the male on the warrant, so he was taken to jail. Towards the end of shift we received a weapon offense in-progress. The caller reported there were two males walking around the apartment complex with a gun. The caller could see the males through his cameras. As officers arrived and began to set up the males were seen running in the distance. Officers lost sight of them and started a search in the area they were last seen, but they were not located. The incident appears to be gang related due to the area where it occurred, and a recent drive-by shooting a few weeks ago near the same apartment. The video shows the suspects lurking around and they appear to be looking for a particular apartment. The firearm appeared to be a rifle in the video. They also wore hoods to cover their face. The intended victim is unknown at this time.
