SUPERVISOR COMMENTS

On 02/06/2026 at approximately 1346 hours, I was dispatched to the area of S. Berkeley Ave and Little St in the City of Turlock regarding a female subject walking in the middle of the roadway and acting erratically. The subject was later identified as Deseret Rene Hohnholt. Upon arrival, I observed Deseret walking in and out of the roadway, creating a traffic hazard. When I contacted, Deseret was not making coherent statements, talking rapidly, not able to stay still and appeared confused. Deseret provided her name and date of birth. A record check through dispatch confirmed she had a misdemeanor warrant out of the Stanislaus County Sheriff's Office with OR revoked status. Deseret was positively identified through a Cal Photo match. I informed Deseret of the warrant and instructed her to place her arms behind her back. I gave her multiple verbal commands to comply; however, she refused. I then attempted to take hold of her arms, at which point she tensed her body and actively resisted being placed in handcuffs. Additional officers on scene assisted me in placing Deseret under arrest. Once secured in my patrol vehicle, Deseret was unable to remain seated and continued moving around in an unsafe manner. For her safety, she was placed in a restraining device. Based on Deseret's erratic behavior, profuse sweating, incoherent statements, and my training and experience, I believed she was under the influence of a controlled substance. A record check also revealed Deseret had prior arrests for being under the influence of a controlled substance. Deseret was transported to the Public Safety Center, where she was booked on the above charges and her outstanding warrant.
