SUPERVISOR COMMENTS

It started being a slow day, but all that changed towards the end of the shift. At approximately 11:49 hours, an officer was dispatched to a report of a male attempting to break into vehicles. Upon arrival, the officer located a subject matching the description. The subject was detained, at which point the officer noted a strong odor of alcohol, slurred speech, and an unsteady gait. The subject was arrested for public intoxication and booked at the Public Safety Center. Right after that, officers responded to multiple emergency calls regarding a female running across a roadway screaming for help during a fight with a male. Upon arrival, officers located a male suspect who violently resisted detention, requiring multiple officers to safely take him to the ground and secure him in handcuffs. The victim stated the suspect assaulted her and caused a laceration to her hand with a knife. The victim also reported that the suspect held a knife to her throat and forced her to engage in sexual intercourse following a dispute over money. Detectives assumed control of the case, served a search warrant at the scene, and facilitated medical forensic exams for both parties.

SUPERVISOR COMMENTS

It was a decent shift with steady calls and traffic stops. Calls continued to gradually come in well into the morning hours. Officers were dispatched to an assault & battery. After investigating, it was determined a male came home very late (or early in the morning) intoxicated. When his wife questioned him about where he was an argument started. The male decided to punch his wife two times on the back side of her head leaving a golf ball size lump. The male was belligerent with officers and denied the allegations. He was arrested and booked on domestic violence charges. Officers also responded to an auto burglary in-progress. The victim saw a male standing near her car with the doors open. The male ran when he realized the RP saw him and abandoned the stolen property he had at the corner of the street. Officers located the male walking nearby minutes later and detained him. The victim was able to provide a positive identification of his as the suspect and wanted him arrested. He was also intoxicated and taken to jail.
