### **SUPERVISOR COMMENTS**

Today, dayshift experienced a high volume of activity today, marked by several arrests involving domestic disputes and alcohol-related offenses. Early in the shift, officers took a male subject into custody for elder abuse and DWI after he arrived home in an intoxicated state and physically assaulted his elderly father. The momentum continued just a few hours later when units responded to a separate family disturbance, resulting in the arrest of a female juvenile who had slapped her mother during a heated argument. These incidents, alongside various other calls for service, made for a demanding and productive day for the shift.

He then approached the victim and began firing numerous gunshots at him, striking him several times. The victim was taken to the hospital for treatment. The investigation led to the whereabouts of the suspect. Detectives were called out and SWAT responded. After several hours the suspect was taken into custody.
