#### **KEEP AN EYE ON YOUR TAX DOLLARS**

Measure L is the Transportation Ordinance and Expenditure Plan approved by Stanislaus County voters on November 8, 2016. The measure raises the sales tax in Stanislaus County by one-half cent for a total period of 25 years to improve our local streets and roads, improve connectivity and reduce congestion. This money is administered by the Stanislaus Council of Governments (StanCOG) and pays for specific voter-approved transportation projects for local street and road improvements, and regional projects and transit programs specified in the Plan.

Measure L calls for an independent Citizens Oversight Committee to oversee compliance with the Ordinance as specified in the Transportation Ordinance and Plan.

### The responsibilities of the 10-member Measure L Citizens Oversight Committee are to:

- Ensure all transportation revenue collected from Measure L is spent in accordance with the Measure L Ordinance and Expenditure Plan;
- Hold public meetings as necessary regarding the expenditure and status of funds generated by Measure L;
- Review independent audits of the expenditure of tax funds and implementation of the programs and projects in the Expenditure Plan; and
- Issue an annual report on its findings regarding compliance with the requirements of the Expenditure Plan and the Ordinance to the StanCOG Board.

#### **HOW ARE MEMBERS CHOSEN?**

be chosen by the City Council or Board of Supervisors they represent. All applications will be sent to StanCOG and then will be provided to the member agencies for following criteria: their review. Staff at each agency will individually screen all applications, and conduct interviews and recommend candidates for consideration by the elected officials.

Measure L Citizens Oversight Committee members represent each of StanCOG's member agencies. At this time, each agency will appoint one member to represent its residents.

The terms for the committee members will begin July 1, 2017. The representatives will serve a three to five-year term which expires between June 30, 2020 and June 30, 2022. This is a volunteer position and no monetary compensation will be paid to committee members. The chairperson will be selected by the members of the committee after it has been seated.

### WHO CAN APPLY TO SERVE?

Measure L Citizens Oversight Committee candidates will Any Stanislaus County citizen 18 years or older may apply to serve on the Measure L Citizens Oversight Committee. Potential candidates will be reviewed on the basis of the

- Commitment and ability to participate in Citizens Oversight Committee meetings for a three to five-vear term from July 1,2017 to between June 30, 2020 and June 30, 2022. The Committee will maintain time and meeting requirements. The Committee will meet quarterly.
- Demonstrated interest and history of participation in community activities, with special emphasis on transportation-related activities.
- Lack of financial conflict of interest with respect to the allocation of sales tax revenue generated by Measure L. All Citizens Oversight Committee members are required to sign a conflict of interest form when accepting appointment.
- Elected or appointed city, district, county, state or federal officials are not eligible to serve.
- Members of any StanCOG Standing Committee or other Authority are not eligible to serve.
